What incentives are available for electric vehicles in Australia?

There are several government programs and support incentives to encourage the uptake of electric vehicles (EVs) in Australia. Some state and territory governments offer additional rebates and discounts for EV buyers, in addition to support by the Australian Government.

Which vehicles are eligible for a government plug-in Grant?

Only vehicles that have been approved by the government are eligible. The discount you can get depends on the type of vehicle. The types of eligible vehicles are: Check which new hybrid and electric vehicles (EV), including cars, vans, trucks and motorbikes, are eligible for a government plug-in grant.

Can I get a tax credit for a new EV?

Find information on credits for used clean vehicles, qualified commercial clean vehicles and new plug-in EVs purchased before 2023. You may qualify for a credit up to \$7,500 under Internal Revenue Code Section 30D if you buy a new, qualified plug-in EV or fuel cell electric vehicle (FCV). The credit is available to individuals and their businesses.
