

# What taxes are levied on the export of photovoltaic panels

What is the new tax rebate rate for photovoltaic products?

In a joint statement issued by the Ministry of Finance and the State Taxation Administration, it was revealed that the export tax rebate rate for photovoltaic products, along with batteries and certain non-metallic mineral products, will be reduced from 13% to 9%.

Will China reduce the export tax rebate for solar panels?

The Chinese Ministry of Finance and the State Administration of Taxation have revealed that the country will reduce the export tax rebate for 209 products, including solar PV cells and modules from 13% to 9%, starting from December 1, 2024.

Does China's photovoltaic industry need tax rebates?

Since the second half of the year, the industry has proposed a variety of supply reform methods such as production restrictions and price restrictions, and policy adjustments on export tax rebates have also been discussed. We believe that the competitiveness of Chinese photovoltaic enterprises does not require tax rebate benefits at all.

When will photovoltaic export rebates be eliminated in China?

China will eliminate value-added tax (VAT) export rebates for photovoltaic products from April 1, 2026, according to a joint notice released on Jan. 9 by the Ministry of Finance of the People's Republic of China and the State Taxation Administration.

The export tax refund rate for certain products, including refined oil, photovoltaic products, batteries, and some non-metallic mineral products, will be reduced from 13% to 9%.
